Youth Leadership Symposium 2024

Dear Regional Ministry Partners,

Last fall we introduced a new model of leadership development and the results were beyond our expectations. Now, we are launching the registration for our 2024 cohort and hope you can help share that invitation with the congregations and youth you serve.

Youth Leadership Symposium brings together youth from the Christian Church (Disciples of Christ) and the United Church of Christ to learn how to lead in a local congregation. These are skills that will also serve them well beyond the Church.

The primary learning experience is a leadership project. Each youth designs and leads their own project in their local congregation. This project will give them a chance to apply all they learn and express their own gifts and passions.

Every congregation is invited to have one youth (high school age) and one adult for free. Participation includes three Saturday events, reading and research, interviews with Church leaders, and anything required for their personal project.

Youth who complete the YLS are eligible for leadership scholarships at Church Related Colleges and Universities, just like those who have served on a Regional or Conference youth leadership team.

Our 2023 participants did some amazing things:

- Cleared overgrown church property with goats in preparation for a community garden.
- Transformed church fellowship time with light weight furniture and better organization.
- Led children's Sunday School in lessons on creation care.
- Hosted a "back to school" carnival with games and donations of school supplies.
- Organized a volleyball tournament to connect the church and welcome community.

Participants can Zoom from home, or meet with others near them in a "pod" to participate.

If your Region would like to host a pod, let us know so we can help you set it up.

Last year, Pods were hosted by Chapman University and Lynchburg University and we expect more in 2024.

The Proclamation Project of the Christian Church (Disciples of Christ) exists to equip and empower Disciples preachers to proclaim the good news. By providing preachers with new resources, collegial support, and opportunities for education, the project will help Disciples preach the good news in their congregations and beyond.

The Christian Church (Disciples of Christ) has received a grant from Lilly Endowment Inc. to help support the Proclamation Project. Have you ever experienced a process that shifted your world? What would it look like for members of the Christian Church (Disciples of Christ) to hear storytellers and engage our narratives? And what kind of church might we have if we imagined a narrative of a shared future?

The Church Narrative Project aims to facilitate the collectively developed preferred narrative of the shared future of the Christian Church (Disciples of Christ). Through StoryHour gatherings followed by an ongoing series of engagements in the Transforming Community Conferencing process, the whole church will participate in a shared process of transformation in person and online not just learn about transformation. Through a facilitated process of interaction and dialogue led by Rev. Dr. David Anderson Hooker, the Church Narrative Project will engage participants in difficult and faithful work towards that aim.

The preferred narrative of our shared future is about who God is calling us to be in light of who we have been, who we are, and how we imagine we might meet God in the future given those two realities. It's about imagining a future by being honest about the stories that make us who we are as a church, and deciding together which stories to carry forward and which may not serve our shared future. The preferred narrative of the future will encompass the tenets of being anti-racist and pro-reconciling, and yet goes far beyond antiracism to state a positive and affirmative vision of the church as a result.

One of the guiding scriptures Dr. Hooker engages in the process is Luke 17:21 (NRSV) “nor will they say, ‘Look, here it is!’ or ‘There it is!’ For, in fact, the kingdom of God is among you.”

The process will answer a question of faithfulness: ***“When we as a church are manifesting the full power of our witness, who/what will we then be?”***

Indiana Region calls next Regional Minister

The Regional Board of the Christian Church (Disciples of Christ) in Indiana has called **Rev. Dr. Christal L. Williams** to serve as the next Regional Minister. The historic decision was made with a unanimous vote of the Board during a called meeting on September 2, 2023. Rev. Dr. Williams is the first Black woman called to serve as Indiana Regional Minister and will begin her ministry here in January 2024.

“This is a momentous day for the Indiana Region,” says Matt Rosine, chair of the Search Committee. “Dr. Williams personifies the leadership qualities, character, joy, and passion to lead our Region into God’s bright future.”

Rev. Dr. Williams currently serves as the Regional Minister and President of the Christian Church in Tennessee, a position she has held since 2016. Prior to her ministry in Tennessee, she served 17 years as Associate Regional Minister in the Illinois/Wisconsin Region. She understands congregational dynamics and employs a style of leadership that many people describe as “grace-filled and truth-telling.” She possesses a bold faith in Jesus Christ and a deep love for God’s people.

Born in Cleveland, OH, Christal is a graduate of Jarvis Christian University (Hawkins, TX) and Christian Theological Seminary (Indianapolis, IN). She received her Doctor of Ministry from United Theological Seminary in Dayton, OH. She is a former Trustee of Christian Theological Seminary and currently serves on the Board of Directors for the Christian Church Foundation and the Executive Committee for International Disciples Women’s Ministries. She was ordained in 1998 at Southport Christian Church in Indianapolis, IN.

Her references use the following words to describe Christal:

“Christal is personable, has a good sense of humor, and loves the church. She is direct yet caring. She speaks her mind without denigrating others. She is a wonderful preacher, who can break out into song when inspired.”

“Christal is creative and brings joy to her work wherever she goes. She has a strong faith which sustains her and is contagious and from which she teaches and leads.”

“Dr. Christal doesn’t do the work alone. She calls on leaders, whether boards, commissions, or task groups, to show up and be present and do the work together. She knows that the health and well-being of our church depends on all of us working together. She is also a prophetic truth-teller, meaning you know exactly what she is thinking and what she believes God has called her and the church to do.”

“She is a leader, overcomer, administrator, survivor, and lover of people as God commanded.”

At its meeting, the Regional Board also called Rev. Carolyn Reed to serve as Acting Regional Minister through the end of 2023. Carolyn has faithfully served as Associate Regional Minister in Indiana for the past 24 years. She will continue to provide care and leadership to congregations and clergy in the Region during this time of transition.
